LOCAL NON-PROFIT CEO SALARIES – UPDATED

"The Cincinnati Enquirer" and "The Cincinnati Business Courier" regularly report the annual compensation of local public and private company CEOs, government officials and employees of area educational institutions. Missing from these reports has been the compensation of the CEOs of area non-profit organizations. This information seems as worthy of review as that previously reported for others and may be of general interest as many of these organizations receive public funding either through taxation or charitable contributions.
